WEST ZONE CONFERENCE ON LAND PROCUREMENT FOR URBAN DEVELOPMENT

The West Zone Conference on 'Land Procurement for Urban Development' was organized by Maharashtra Regional Chapter (Mumbai) on 8th October 2011 at MRC Mumbai.

In his welcome address Shri S.D. Landge, Chairman MRC(M) stated that all of us are aware that the theme of 'Land Procurement for Urban Development' is very topical because our country is witnessing rapid urbanization, which calls for expansion of towns and cities and rural areas to house ever increasing

urban population. However, it is well known fact that land is limited and needs to be utilized optimally and judiciously because land is a limited resource. We are also aware of the fact that land is the most essential factor for urban development and at the same time land is also required for agriculture and food production without which no community can survive. This is the dilemma of town planners i.e. to see that land is not only made available for housing the people but also earmarked for open spaces,

green areas and forests, which are the lung spaces of our towns and cities.

He further stated that, procuring land for urban development projects through compulsory land acquisition is increasingly becoming difficult. Even as these projects pave the way for new settlements, loss of land through acquisition causes traumatic changes in the lives of landowners and their families. As professionals, we need to look at this issue dispassionately and objectively as it may impact the supply of land for development. Land Acquisition Act, 1894 in force since 117 years is about to be replaced. Land Acquisition and Rehabilitation and Resettlement Bill, 2011 (LARR), which integrates rehabilitation and resettlement process is a step forward because it combines the intertwined elements of land acquisition and rehabilitation and resettlement into a single bill. Thus, the bill strikes a balance between the need to acquire land

for urbanization, and at the same time provide a just, fair and timely compensation to landowners and other affected persons.

Shri Anil Kumar Sule, Chairman, Building Committee, MRC(M) gave highlights of construction work of MRC(M) building, which was done in phases.

Shri Pradeep Kapoor, Secretary General, ITPI, while introducing the subject stated that agriculture contributes only 21 percent to India's GDP but large swathes of India's rural populace still depend upon agriculture for their livelihood. While agriculture demands that fertile and cultivable land be retained, urbanization is in an irreversible process, and cities in India are growing to consume land on their fringes, which may be cultivable. Industrialization and infrastructure building require large parcels of land, and delays in acquiring it, could affect GDP growth as well as investors sentiment. In the wake of this unbridled urban growth and its manifold manifestations, land acquisition and involuntary displacement continue to result in great distress and resistance in many parts of the country.

Shri D. S. Meshram, in his Presidential address noted that urban population of the country, which was 27.75 percent of the total population in 2001 has increased to 30 percent and is likely to surpass 50 percent mark by 2051 i.e. 827 million. As the urban population in 2001 was 363 million, that is to say within another 40 years, urban population would double. Total population of India by 2051 would be more than the population of China but would be settled on a land mass equal to one fourth of China. He also stated that the land man ratio by 2051 would be 0.19 hectare. Quoting statistics he stated that during 1901-2011, total population of the country increased by six times, but urban population increased by 14.5 times while the number of settlements during the same period hardly increased by 4.3 4 times (1,827 to 7,935), which clearly indicates that majority of urban population settled in the existing towns and cities.

For accommodating this urban population it is essential to procure land for urban development. Under prevalent Land Acquisition Act of 1894, land can be acquired for

the public purpose. This issue is now being revisited to broaden the canvas of public purpose. Another issue, which is being debated, is compensation and rehabilitation to the owners of land whose land is likely to be acquired. In this direction Land Acquisition and Rehabilitation and Resettlement Bill, 2011, provides for 80 percent of land to be procured by the promoters and builders by negotiation and 20 percent can be procured by the government. It is also provided in the Bill that if families become landless or loose means of livelihood and become homeless due to acquisition, they are required to be resettled and given jobs or monthly compensation. In urban areas compensation has to be paid at the rate of assessed market value plus 100 percent solatium i.e. two times market value and in rural areas it is more than 4 times. He however brought into focus the other side i.e. in this process the principle of 'eminent domain' would get discarded and also it would become difficult to acquire land even for genuine public purpose as the authorities need to pay more compensation besides resettlement cost and providing jobs. He asked whether it would be possible for local bodies to bear this burden. He flagged whether this situation would discourage acquisition of land for urban development. All such issues have positive and negative impacts, therefore this need to be discussed thread bear.

Shri Meshram was happy to note that this Zonal Congress would be revisiting all the relevant issues like (i) urban development versus agriculture in the wake of the current scenario; (ii) to examine the role of public and private sector towards urban development; (iii) to assess options being worked out by the Centre and various States and UTs for mitigating resistance and

taking up development projects; (iv) to assess available means towards adequate compensation to those affected by development projects; (v) to analyze the current regulatory reforms i.e. the Land Acquisition Act and proposed amendments, the R and R packages, and other Acts being utilized for land procurement; and (vi) to understand the definition of 'public purpose' and justification for the need to procure land.

Shri Bhaskar Wankhede, Municipal Commissioner, Navi Mumbai, Municipal Corporation, in his address stated that large scale acquisition results in encroachments. Almost 163 acres of NMMC land is occupied by slums, which is due to immigration to the NMMC. He called on town planners' community to adopt two prong strategy i.e. to have proactive planning so that immigrants could be adequately settled in a planned manner and steps are taken to control immigration by resorting to rural urbanization. He also brought into focus the issue of urban poverty and suggested that we

should adopt the principle of equal distribution of land resources.

The Chief Guest of the West Zone Conference Shri Sagar Naik, Hon'ble Mayor, Navi Mumbai Municipal Corporation (NMMC), while addressing the conference stated that he himself belongs to the affected people being a farmer whose land has been acquired by CIDCO at a very nominal price. He stated that if land is required for public purpose, then actual price or market value is required to be given to land owners. During acquisition of land there are various other factors which are required to be taken into consideration like settling of families who lose their land. He also brought into focus various other issues like provision of houses to project workers and laborers, solid waste management, etc., and called on town planners' community to take holistic view while planning.

While extending the vote of thanks Shri Jitendra Bhole, Secretary, MRC(M) assured the delegates and Hon'ble Mayor, that issues would be discussed in the Technical Sessions.

from urban areas, and are the major source of climate change which results in disasters like floods, drought, shortage of drinking waters, etc. He also said that earlier there used to be wars for territories but there is likelihood that in future there could be wars between countries for water. He brought into focus another aspect that is rising of sea level and quoted the example of Bangladesh, where if two feet sea level increases, 40 percent of Bangladesh would be affected, which is a major cause of concern. He also called on town planners to adopt the use of non-conventional energy sources, and use of non-polluting modes of transport like cycles, rickshaw. He attracted the attention of the delegates towards high rise buildings constructed with reflective materials. He also desired to introduce the principle of consumption of energy per sq ft not only in buildings but in cities as well.

Shri D. S. Meshram, in his Presidential address drew attention of the delegates to the side effects of climate change. He pointed out that he has noticed himself the effects, being present in Puerto Rico, USA, when devastating hurricane recently destroyed life and property. He also shared his experience of visit to Port Blair,

Karnataka Regional Chapter (KRC)

Karnataka Regional Chapter of the ITPI celebrated the World Habitat Day on 22nd October 2011 at KRC Building on the theme 'Cities and Climate Change'. In his welcome address Prof. (Dr.) Krishnegowda, Chairman, KRC, stated that with increase in population, the number of towns and cities is also bound to increase. As towns and cities increase, it would be responsibility of planners, to plan for this ever increasing population at the same time planners need to take into consideration the aspect of climate

change and needs to plan cities and towns, which are climate friendly.

Kumari Priyahasana, Multi-lingual Cinestar, Director and Producer was the Guest of Honor who stated that through media it would be possible to reach the people and impress upon them, the importance of environment and climate change.

Shri Subir Hari Singh, IAS, and Additional Chief Secretary and Development Commissioner, Government of Karnataka was the Chief Guest of the Session. In his address Shri Singh stated that 70% of the greenhouse gases emission come

Andaman and Nicobar Islands after the disaster of Tsunami, when sea water entered inside towns destroying not only buildings but entered into tanks which were source of drinking water, polluting them forever. Because, salt water mixed with the source of drinking water, it can no longer be used for drinking purposes. After waiting throughout the summer for evaporation which could not totally get rid of salt water, rain water started pouring in. Such are the devastating effects of climate change. Due to climate change ozone layer is depleting, sea level is rising, and global warming is taking place, resulting in melting of snow in the Himalayas.

Cities are the major cause of concern due to their contribution in climate change. Shri Meshram stated that due to manifold increase in population, a majority of the people will settle in the peripheries of the existing towns and cities. He cautioned the delegates that growth of any thing beyond certain limits will always have bad and side effects, which is also true for our cities. We are planning Delhi for 23 million people by 2021 by almost urbanizing the total area of the NCTD, and stated that beyond

2021 there will be no area left for accommodating growth of Delhi within the NCTD. Therefore, it is high time that we address such issues. He also said that we need to undertake 'green planning' in our towns and cities, which consumes less resources.

A vote of thanks was extended by Shri K. Shanker, Secretary, KRC.

Maharashtra Regional Chapter (Nagpur)

Maharashtra Regional Chapter, Nagpur celebrated the World Habitat Day on 15th October 2011 at MRC(N) Building. On this occasion

a workshop on 'Cities and Climate Change' was also organized. In his welcome address Prof. A.M. Deshmukh, Chairman MRC(N) highlighted the importance of the theme and argued that we should focus on sustainable development of towns and cities.

Prof Rajashree Kotharkar, VNIT, Nagpur, in her keynote address underlined the role of cities in modifying the climate at local level, which in turn contributes to global climate change. Due to concentration of population and economic activities in urban areas, these areas are responsible for consumption of the bulk of world's energy. They thus become the single biggest source of global emissions of CO₂. She also emphasized the vulnerability of cities to various effects of climate change including heat waves, and flooding. She called on town planners' community to take a serious note of the complex and multi-layered urban structures of our cities and accordingly find out ways and means to combat climate change.

Shri Sujit Rodge, Secretary MRC(N) proposed a vote of thanks.

ORDINARY BUSINESS

1(a). To consider, and adopt the Audited Statements of Account and the Auditors Report for the year 2010-2011.

Shri Meshram was also instrumental in taking up the issue of starting undergraduate planning courses in country with the help of then Ministry of Education, Government of India and recently with Ministry of Human Resource Development to start four new Schools of Planning. Ministry of HRD has already started two new Schools of Planning at Vijaywada and Bhopal.

ELECTED OFFICE BEARERS (2011-12) OF ITPI

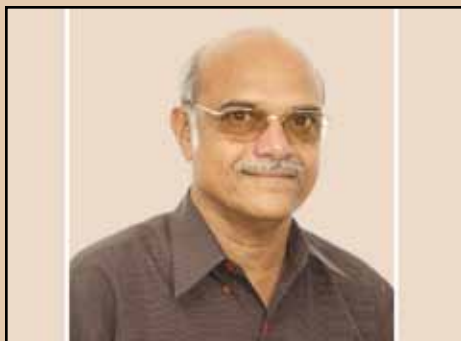
PRESIDENT

Shri D.S. Meshram was elected President of the ITPI for the thirteenth time. Prior to this, he held the prestigious position of the Chief Planner, Town and Country Planning Organization, Government of India for over 12 years and was responsible for elevating the status of the Chief Planner to Joint Secretary in Government of India.

The Model Town and Country Planning Law was revised while he was the Chief Planner to bring it in conformity with the 73rd and

74th Constitution Amendments. After his retirement from the TCPO as Chief Planner, the Government of Utrkhand appointed him as Advisor, Urban Development.

Shri D.S. Meshram was a member of Delhi Development Authority and New Delhi Municipal Council. Due to his initiatives, the ITPI was awarded the work of preparation of 'Urban Development Plan Formulation and Implementation (UDPFI) Guidelines' by the Ministry of Urban Development and Poverty Alleviation in 1996, for which

Shri Aniyam Mathew, elected as Vice-President, ITPI, graduated in civil engineering from the University of Kerala in 1963. He has been a consultant to many NGOs involved in development activities. He also played pivotal role in poverty alleviation programmes organized in southern India by agencies such as the USAID, CIDA and the Government of Belgium. In late 1960s, he was associated with the pioneering works of world renowned architects like Padmasree Laurier Baker OBE. Shri Mathew, former resource person, State Nirmitti Kendra (Low cost building centre), has also made contributions to environment friendly designs and low cost building technologies.

His vast experience with the aid agencies prompted him to pursue town planning education. He passed his postgraduate degree

in Town and Country Planning from the School of Architecture and Planning, Chennai in 1972. In 1975, a German aid agency invited Shri Aniyam Mathew to join them as a planner in their expert team. It was here that he made many environment friendly designs for medium sized projects in different parts of the developing countries. Some of his designs for Health Centers from various climatic zones were adopted by the World Health Organization as type-plans.

He encouraged many professionals to enhance their qualifications by joining postgraduate courses in town planning through Associateship Examination of the ITPI. Shri Mathew has traveled extensively in Europe and India learning about land and the people.

Presently Shri Mathew is a member of the State Level Steering Committee for the preparation of IDDP and LDP, a programme which has attracted national attention. Shri Mathew has been elected as Vice-President of the ITPI for the fourth time.
