
Dear Member

1. As per Bye-law No.36, 18 members of the Council are to be elected from two constituencies as given below: -

**Instructions for filling Nomination Form**

1. In case of nominees who are nominated to more than one Constituency, the Nominee may indicate the particular Constituency to which she / he would like to represent in the event of being elected from more than once Constituency.
2. Each Member is entitled to submit only one Nomination Form and nominate **(maximum) 13 Members for the General Constituency**. She / he is also entitled to nominate a **Chairman of the Regional Chapter** to which she / he belongs **for the Special Constituency** provided the elections of Chapter for 2017-18 are held.
3. No Nominee can support her / his own nomination.
4. The Nominee, nominating Member and supporting Members shall not be in arrears of subscription otherwise the Nomination and Nomination Form shall be declared invalid.
5. **Information about Nominees (not exceeding one page)** should be sent along with the Nomination Form indicating Name, Registration Number, Designation, Positions held in ITPI / Chapter and contribution in ITPI activities, etc.
