The Fourth Semester Orientation Classes for students will be held **26th December, 2017 to 28th December, 2017** for which the students are also required to send their confirmation for the Orientation Classes along with the fees of **Rs.1,500/- (Rupees One Thousand Five Hundred only) by Demand Draft in favour of Institute of Town Planners, India**, payable at New Delhi as an Orientation Classes Fee and register for Fourth Semester by paying a demand draft of **Rs.4,500/- (Four Thousand Five Hundred Only/-) in favour of Institute of Town Planners, India, payable at New Delhi before 9th December, 2017.**

It may further be informed that those student not attended the orientation classes, will also not be permitted to appear in the examination and those student failing in two subjects (including Portfolio) of Third semester which were carried forward to Fourth semester and continues to fail in one/two subjects (including Portfolio) of Second semester he/she will not be allowed to appear in the fourth semester. A student unless clears all the subjects of semester-II he/she will not be eligible for semester-IV. The student must clear these subjects in the subsequent semester examination.

It may also be clarified that it is not possible to provide the accommodation to the candidates attending the Orientation Classes at ITPI, therefore, you are requested to make your own arrangements of accommodation, etc.
